- Meet and, where appropriate, exceed the requirements of all relevant legislation. Where no regulation exists we shall set our own standards informed by relevant codes of practice and guidelines;
- Minimise waste and pollution and develop and operate environmentally sound waste management procedures; continue to reduce the consumption of energy and water usage and to incorporate long term strategies for energy efficiency and water consumption into planning and development;
- Quantify and reduce its environmental impacts;
- Allocate sufficient resources to enable us to achieve our objectives and targets;
- Promote a sustainable purchasing policy which seeks where possible to take account of environmental and social factors when making purchasing decisions;

- Cleaning materials for all premises will be biodegradable and environmentally friendly;
- Wild life and surrounding habitats, trees, flora, fauna archaeological and heritage remains are protected as appropriate;
- Maintain the grounds and buildings of Signposts in an environmentally sensitive way, having regard to protection of local natural habitats and preservation of biological diversity;
- Endeavour to recycle and use recycled materials where possible.

To reduce the environmental impact Signposts will:

- Only buy supplies when necessary and minimise the amount of materials consumed.
- Explore systems whereby products can be reused rather than thrown away.
- Source products which are made from recycled materials and/or are Fair Trade
- Select a more durable, environmentally friendly alternative
- Maintain and repair furniture, equipment and other products as to extend its life.
- Buy energy efficient appliances and equipment.
- Encourage Car sharing and use of public transport where ever possible to reduce the impact on pollution and traffic congestion and promote the use of bicycles when travelling short distances.
- pass on, whenever possible, items that we cannot use or re-use to other organisations e.g. bric-a-brac to charity shops and wood to community allotments
- undertake building work with environmental issues in mind e.g. double-glazing, thermostatic valves and eco-roof insulation
